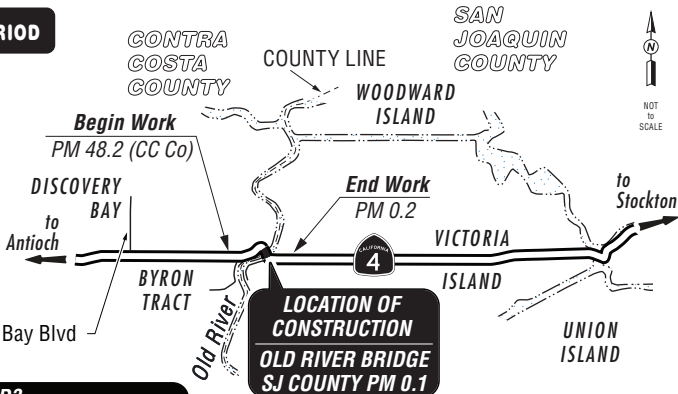

If there are no major comments or requests for a hearing, Caltrans will proceed with the project's design.



#### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to preserve the Old River Bridge (Number 29-0045) at post mile 0.01 at the San Joaquin and Contra Costa county line on State Route 4. To preserve the bridge, the project would place a polyester concrete overlay and paint the bridge. The old timber waling and the fenders on the north side of Pier 3 would be replaced, and the south side of Pier 2 would be supported with new high-density polyethylene walers mounted to the existing timber piles. An abandoned Caltrans-owned one-car garage on the southwest levee would be removed. The approach rail on both sides of the bridge would be replaced with the current standard Midwest Guardrail System.

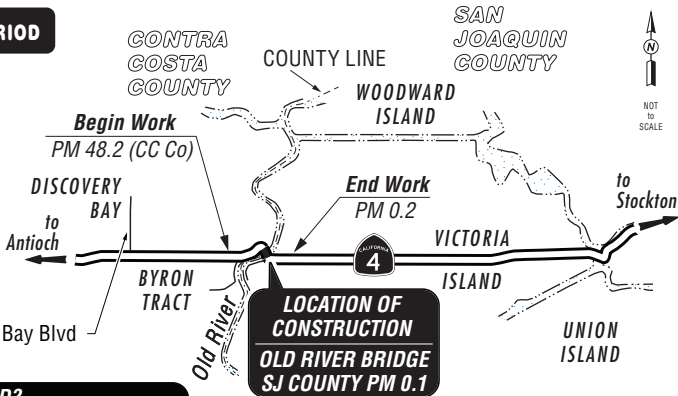

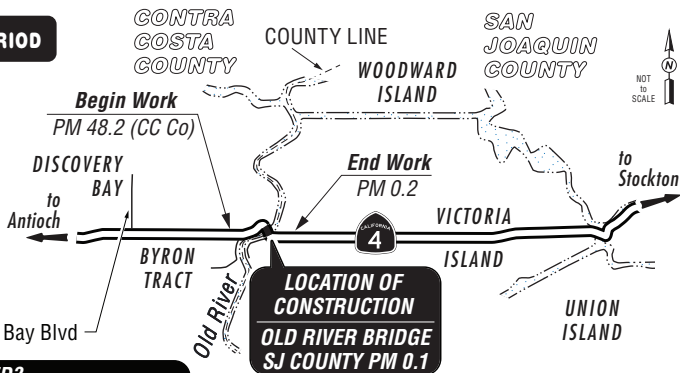
