Description of nature and purpose of the Project: The project proposes a Coastal Development Permit (CDP) to demolish an existing residence and storage building, and to build a new 1,311 square-foot (sf), 2-story single family residence with 438 sf detached garage, covered patios, and decks, on a 0.06-acre site. The project is in the RM-2-4 (Residential Multiple Unit) Zone, of the Ocean Beach Community Plan, Coastal Overlay Zone (Non-Appealable 2), Coastal Height Limit Overlay Zone, Ocean Beach Cottage Emerging District, Transit Priority Area, Residential Tandem Parking Overlay Zone, Parking Impact Overlay Zone (Coastal Impact/Beach Impact), 65-70 dBA Airport Noise Contours (CNEL), Airport Land Use Compatibility Overlay Zone, Airport Approach Overlay Zone, Airport Influence Area (San Diego International Airport (SDIA), Review Area 1), and the Federal Aviation Administration Part 77 Notification (SDIA and North Island Naval Air Station) area. The community plan designates the site as medium-density residential (15-29 dwelling units per acre).


