Project Title: Mt Woodson Gateway County Preserve Parking Lot Project

Project Location (include county): The project is approximately 6.48 acres on County-owned property within the existing Mt Woodson Gateway County Preserve located at the base of the Mt Woodson trail network adjacent to State Route 67 (SR-67). The project site is within the unincorporated community of Ramona in San Diego County as identified on two parcels (APNs 2780907600 and 2780810200).

Project Description: Currently, there is an active safety concern for visitors parking on SR-67 shoulders, and neighboring streets to access the Mt Woodson trail network. The proposed project would provide a safe, alternative parking option within the Mt Woodson Gateway County Preserve by creating 100+ parking spots, and an accessible staging area, including a kiosk, portable restrooms, and trash receptacles, for the existing trail users. Additionally, the proposed project, as approved by and in accordance with Caltrans, will include the re-striping of SR-67 to delineate a turn lane northbound accessing the site, a deceleration lane southbound, and a monument sign within the right-of-way.
