Description of Nature, Purpose, and Beneficiaries of Project:

The Caldor Hazard Tree and Fuel Reduction project will reduce fuel loading and remove fire-killed or weakened trees, trees that are likely to die because of fire damage, and other trees that pose a hazard to roads, trails, private property boundaries and developed recreation sites impacted by the Caldor Fire. The project will also include native tree planting in areas where natural tree regeneration is not likely to occur due to the fire severity. Planting trees will hasten recovery back to a fire adapted forest rather than a shrub dominated landscape that poses a greater fire risk to neighboring communities. Native vegetation will be planted in priority areas denuded by suppression activities which will prevent the conversion to non-fire adapted invasive plants that also increases fire risk.
