**PROJECT LOCATION:** The service contract area relates to two adjacent parcels, APNs 0262-021-09 and 0262-021-13, encompassing a total of approximately 9.2 acres, generally located on the east side of Cajon Boulevard, immediately south of the Union Pacific Railroad, within the City of San Bernardino's unincorporated northwestern sphere of influence.

**PROJECT DESCRIPTION:** Authorization of a service extension agreement submitted by the City of San Bernardino to provide sewer service outside its boundaries to a proposed truck terminal and cargo terminal on the 9.2-acre project site.
