Project Location: The Project is located at 2351 Circadian Way in the City of Santa Rosa, in Sonoma County on Assessor's Parcel Number 035-133-009-000.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Processor License submitted on February 7, 2022, by 2CW Productions, INC. 2CW Productions, INC. The applicant will process cannabis, and store cannabis products for transport-only distribution and manufacturing in a 17,000 square foot facility. A separate Notice of Exemption was filed for the distribution and manufacturing license.

Project Activities:

The Project will consist of the processing of cannabis in an existing building also utilized for the transport-only distribution license and the manufacturing license. The Project will not expand the existing facility and no modifications or improvements are required. The site has been operating as a cannabis facility since 2018.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building which was formerly used as a brewery facility with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
