

All work will be done within the existing edge of pavement. No work will be performed on bridge decks. There will be no increase in disturbed soil area or impervious surface. Removal of thermoplastic pavement markings will be required.

**Purpose:** The purpose of the project is to provide efficient, easily maintained pavement that requires minimum maintenance for multiple years, as well as increase safety for travelers and workers.

**Need:** The existing roadway and pavement surface is in a poor condition.

### **Right-of-Way**

Acquisitions or TCEs will not be needed for this project due to work being confined to ROW.

### **Staging/Stockpiling**

Multiple locations are available for staging/stockpiling use. No grading and/or site preparation will occur. Approved staging locations include: PM 19.05 NB, PM 19.90 SB, 22.95 NB, PM 23.03 - 24.40 SB.

### **Disposal/Borrow Sites**

The project would not utilize borrowed material. If any excess material is generated, it will be a small enough quantity to become property of the contractor.

### **Utilities**

All utilities in proximity to the locations of work would be protected in place; no utility conflicts are anticipated.

### **Coordination/Consultation**

Based on the scope of the project, no outside coordination or consultation was required.

### **Permits**

No permits are necessary with current scope of work.
