PROJECT LOCATION: The project site is 300 feet east of Cherryland Ave. and 180 feet south of Joseph Leon Ln. and Towers Pl., Stockton, San Joaquin County. (APN/Address: 087-090-67 / 3600 N. Towers Pl., Stockton) (Supervisorial District: 4)

PROJECT DESCRIPTION: Minor Subdivision application to subdivide an existing 10.68-acre parcel into 4 parcels. Parcel 1 to contain 2.95 acres. Parcel 2 to contain 2.0 acres. Parcel 3 to contain 3.62 acres. Parcel 4 to contain 2.12 acres. Parcels 1, 2, 3, and 4 will utilize a private access easement from Towers Place. Each parcel will utilize new private wells and on-site wastewater treatment systems. Storm water drainage is natural. This parcel is not under a Williamson Act contract.

The Property is zoned R-R (Rural Residential) and the General Plan designation is R/R (Rural Residential).
