The Proposed Project involves the demolition of all existing on-site buildings, totaling 296,630 square feet of building space, parking lots, and associated improvements. The Proposed Project consists of a new 190,860-square foot tilt-up concrete industrial building, constituting of 180,860 square feet of industrial uses and 10,000 square feet of office uses. The proposed building has been designed to accommodate up to two tenants with a wide variety of uses, including light assembly, manufacturing, e-commerce, and warehousing/distribution.
