The project site is located on the southeast side of Tollhouse Road (State Route 168) at its intersection with Newmark Road approximately 10 miles northeast of the City of Clovis (APN: 150-141-33 & 35) (14147 Tollhouse Road) (Sup. Dist. 1).

Allow continued surface mining operation (granite quarry) with facilities approved by CUP No. 2928 for an additional 50 years to January 18, 2071, on two contiguous parcels totaling 142 acres in the AL-40 (Limited Agricultural, 40-acre minimum parcel size) Zone District.
9. **Surrounding land uses and setting: Briefly describe the project's surroundings:**  
The project area is made up of grazing land with scattered single-family homesites. Tollhouse Road (State Route 168) runs along westerly boundary of the project site. The nearest city, City of Clovis, is approximately 10 miles southwest of the site.
10. **Other public agencies whose approval is required (e.g., permits, financing approval, or participation agreement.)**

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code Section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code Section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code Section 21082.3(c) contains provisions specific to confidentiality.

Pursuant to Assembly Bill (AB) 52, the project information was routed to the Picayune Rancheria of the Chukchansi Indians, Dumna Wo Wah Tribal Government, Table Mountain Rancheria and Santa Rosa Rancheria Tachi Yokut Tribe offering them an opportunity to consult under Public Resources Code (PRC) Section 21080.3(b) with a 30-day window to formally respond to the County letter. No tribe requested for consultation within the comment period. However, in the unlikely event, potential impacts associated with the tribal cultural resources that may be encountered during Project activities would be less than significant with implementation of Mitigation Measure included in Section V. CULTURAL RESOURCES of the Initial Study for the project.



**INITIAL STUDY
