The City is implementing a project to protect and maintain existing infrastructure along Esplanade Avenue, including the public street and some underground utilities, which are currently threatened by coastal bluff retreat. The proposed project design includes several structural elements to mitigate wave related bluff erosion including a buried sheetpile wall at the toe of the bluff, a cap beam on top of the sheetpile wall, and a shotcrete (sprayed concrete) wall secured to the bluff face with tieback rods/tendons drilled into the bluff face.
