On Interstate 8 (I-8) in unincorporated Alpine, County of San Diego the proposed project would remove approximately 2,100 feet of existing asphalt concrete dike (Type A) and place Hot Mix Asphalt Dike (Type D) along the inside shoulder on westbound I-8 just west of Tavern Road. There would be no excavation or ground disturbance. Any project changes will require further Environmental review. See the Environmental Commitment Record for further conditions. No new right of way required.
