**Description of Nature, Purpose, and Beneficiaries of Project:**

The project consists of twelve work sites, located in four recreational areas: Turtle Bay East, Parkview Park, Blue Gravel Mine Trail, and Enterprise Park. The project will repair seating and viewing areas; as well as trail surfaces, trail embankments, and culverts. Work will include vegetation removal, demolition, excavation, grading, sediment removal, culvert cleaning, erosion repair, culvert installation, and placement of rock slope protection. Construction is anticipated to be completed in the fall of 2023.

**Name of Public Agency Approving Project:**

This is to advise that the Central Valley Regional Water Quality Control Board, as Responsible Agency, has approved the above-described project on 13 July 2023 and has made the following determinations regarding the above-described project:

1. The Central Valley Regional Water Quality Control Board considered the Initial Study/Mitigated Negative Declaration as prepared by the City of Redding.
