**NOTICE OF INTENT TO ADOPT
AN INITIAL STUDY / MITIGATED NEGATIVE DECLARATION**

PROJECT TITLE: Bowman Charter School Recreational Field Project

SUBJECT: Notice of Intent to Adopt an Initial Study/ Mitigated Negative Declaration

NOTICE IS HEREBY GIVEN that the Ackerman Charter School District (District), as Lead Agency for the Project, has prepared a Draft Initial Study and Mitigated Negative Declaration (IS/MND) for the Bowman Charter School Recreational Field Project, pursuant to the California Environmental Quality Act (CEQA) (Public Resources Code [PRC], Division 13, Section 21000 et seq. [CEQA Statute] and the California Code of Regulations [CCR], Title 14, Division 6, Chapter 3, Section 15000 et seq. [CEQA Guidelines]). An IS/MND is a detailed informational document that analyzes a proposed project's potentially significant environmental impacts, as well as identifying ways to minimize and mitigate such effects. The purpose of this notice is to solicit comments regarding the content of the Draft IS/MND.

PROJECT LOCATION: 13777 Bowman Road, Auburn, CA 95603

PROJECT DESCRIPTION: The Ackerman Charter School District (District) proposes to develop recreational fields, an associated parking lot, and equipment/field storage buildings on APNs 053-090-023 (0.1394 acre) and 053-090-024 (6 acres) of the Bowman Charter School campus.

POTENTIAL ENVIRONMENTAL EFFECTS: Pursuant to CEQA Guidelines Section 15064(f)(2) and based on the environmental analysis in the Initial Study, the District has determined that a Mitigated Negative Declaration is the appropriate level of environmental documentation for the Project.

PUBLIC REVIEW PERIOD: The District will make this NOI and the IS/MND (pursuant to California Code of Regulations, Title 14, Section 15072) available for public review and comment from October 26, 2022, to November 25, 2022.
