

NOTICE OF THE RELEASE FOR PUBLIC REVIEW AND TO ADOPT A MITIGATED **NEGATIVE** DECLARATION BY THE CITY OF SIMI VALLEY ON Z-S-2022-0002/PD-S-2022-0001/AHA-2022-0001 TO CHANGE THE ZONING FOR A .22-ACRE PORTION OF A VACANT 4.57-ACRE SITE FROM COMMERCIAL OFFICE TO RESIDENTIAL VERY HIGH DENSITY. IN ORDER TO CONSTRUCT Α NEW 83 UNIT **MULTI-FAMILY** RESIDENTIAL BUILDING WITH FOUR AFFORDABLE UNITS, AND AN AFFORDABLE HOUSING AGREEMENT ON A 3.11-ACRE PORTION OF A 4.57-ACRE VACANT LOT LOCATED AT 1850 HEYWOOD STREET

NOTICE IS HEREBY GIVEN of the release for public review of a Mitigated Negative Declaration for Z-S-2022-0002/PD-S-2022-0001/AHA-2022-0001, for the application of Heywood Street Associates LLC. The project consists of a Zone Change (Z-S-2022-0002) from Commercial Office (CO) to Residential Very High Density (RVH) for a .22-acre portion of a 4.57-acre site, for the construction of a new 83-unit multi-family residential building (PD-S-2022-0001), with four affordable units, on a 3.11-acre portion of a 4.57-acre vacant lot located at 1850 Heywood Street. The project also includes a density bonus, concessions, and waivers as part of the Affordable Housing Agreement (AHA-2022-0001).

Based upon the results of the Initial Study prepared for the project, it has been determined that the project would not have a potential for a significant impact on the environment; therefore, a Mitigated Negative Declaration has been prepared. The public review period for the Mitigated Negative Declaration is from October 28, 2022, through November 16, 2022.
