Comments will be accepted from November 10 to December 12, 2022.


If there are no major comments or requests for a hearing, Caltrans will proceed with the project's design.

#### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to rehabilitate nine existing drainage systems at eight locations on State Route 1 in Monterey County, from post mile 27.76 to post mile 70.87. Existing drainage systems at the proposed locations have exceeded their design life and have deteriorated or failed. The project work includes replacing or rehabilitating existing culverts and replacing or upgrading end treatments and headwalls as needed.

#### WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration. This no
