

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

WHO: Project Applicant, Joseph Riccardo, **Permit Sonoma File No. UPC17-0031**

WHAT: Applicant proposes a commercial cannabis cultivation operation, consisting of 10,000 square feet of mixed-light cultivation, 9,000 square feet of mixed-light propagation, 33,560 square feet of medium outdoor cultivation, and 5,000 square feet of associated processing. Operations are proposed to occur 24 hours per day, 7 days a week as needed. Deliveries, shipping, and processing operations are proposed from 8:00 am to 5:00 pm Monday through Friday. The operation will employ up to 10 employees consisting of part time and full time employees. The project does not include a distribution. The project is located on a 100 acre parcel located at 4233 Browns Lane, Petaluma. **APN 068-010-016. Supervisorial District 2.**

Parcel Zoning: LEA (Land Extensive Agriculture), B6 60 (60-acre minimum density per residence), RC 50/50 (Riparian Corridor 50 feet/50 feet), VOH (Valley Oak Habitat)

In accordance with Public Resource Code and CEQA Guidelines, the County of Sonoma provides notice to agencies and interested parties that it is releasing a final Initial Study and Mitigated Negative Declaration IS/MND for the project. The IS/MND did not find potential environmental impacts that could not be mitigated to a less-than-significant level. The IS/MND is available at Permit Sonoma at 2550 Ventura Avenue, Santa Rosa, CA 95403.

WHERE & WHEN:

After the close of the IS/MND public review period, the Sonoma County Board of Supervisors is **tentatively** scheduled to hold a public hearing on December 13, 2022 to consider the adoption of the IS/MND. In accordance with AB 361, Governor Newsom's March 4, 2020 State of Emergency due to the COVID-19 pandemic, Sonoma County Public Health Officer's Recommendation for Teleconferenced Meetings, and the Sonoma County Board of Supervisors Resolution 21-0399, this meeting will be conducted via videoconference, with modified procedures by which members of the public may observe and offer public comment at the Board chambers. **Members of the public are encouraged to watch, listen, and participate in the hearing through Zoom or by phone call, though in person public participation is available.** A final hearing notice containing instructions on how to join the meeting will be issued ten (10) days prior to the confirmed hearing date.
