**Project Description:** (please use a separate page if necessary)

The project would construct a 3-megawatt (MW) solar photovoltaic (PV) electric generating facility on approximately 18.3 acres of the 40-acre parcel, south of the existing on-site residences with access via South Arbor Way. There are two project areas bisected by an irrigation canal, which is avoided with a 40-foot setback. The solar facilities would consist of a ground-mounted, single-axis tracking system featuring 8,316 PV panels and 24 string inverters. The project would be equipped with energy storage technology (battery energy storage system [BESS]) that would allow on-site renewable energy generation to be stored and dispatched onto the grid when needed.
