Description of Nature, Purpose and Beneficiaries of Project:

The project involves routine vegetation maintenance conducted within established fuel reduction zones to reduce the risk of a wildfire and to reduce wildfire intensity and rate of spread for any fires in and around the wildland-urban interface of Camp Josepho in the Pacific Palisades region of the Santa Monica Mountains. The project consists of performing hazardous fuel reduction at Camp Josepho and along the paved Sullivan Fire Road to bring these areas back into compliance with the City's brush clearance ordinance (Los Angeles Municipal Code Section 57.322) for owners of property within the Very High Fire Hazard Severity Zone. This involves trimming and removing highly flammable material up to 10 feet away from road edges and within 200 feet of camp structures/buildings.

Reasons why project is exempt:

The project is exempt pursuant to CEQA Guidelines Section 15301, Class 1 Categorical Exemption: Existing Facilities. The project involves the maintenance of existing facilities and negligible or no expansion of use beyond that which is existing. The project specifically falls under one of the nonexclusive examples cited under CEQA Guidelines Section 15301(h): "Maintenance of existing landscaping, native growth, and water supply reservoirs." The project entails routine vegetation maintenance along the primary camp access road and camp facilities, with the intent of meeting Los Angeles Fire Department brush clearance requirements for the Very High Fire Hazard Severity Zone. Portions of the project are also exempt pursuant to CEQA Guidelines Section 15304, Class 4 Categorical Exemption: Minor Alterations to Land. A Class 4 Exemption consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry and agricultural purposes. These actions include fuel management activities conducted in accordance with public fire agency determinations (Section 15304(i)).
