DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF THE PROJECT:

The proposed project consists of a Use Permit for the relocation of a 6' high solid wood fence located within the front yard setback on a 1.9-acre parcel zoned Rural Residential (RR) B6 10, Floodway (F1), Floodplain (F2), Scenic Resource (SR), Riparian Corridor (RC) 100/50, and Valley Oak Habitat (VOH) combining zones. This Use Permit is to satisfy the requirements of Sonoma County Code Violations VCM20-0557, VPL20-0251, and VPL20-0252. The proposed use is consistent with the Sonoma County General Plan and Sonoma County Zoning Code.

EXEMPT STATUS:

Categorical Exemptions Section 15303 for New Construction or Conversion of Small Structures.

REASON WHY THIS PROJECT IS EXEMPT:

The proposed project is categorically exempt from the provisions of the California Environmental Quality Act pursuant to the Provisions of Title 14 of the California Administrative Code, Section 15303 (New Construction or Conversion of Small Structures), which provides for the construction of small accessory structures such as fences.

No exceptions listed under Section 15300.2 apply. There is no reasonable possibility that the project would have a significant effect on the environment.

This Notice of Exemption is filed pursuant to the provisions of Section 10562 of the State CEQA Guidelines.
