Allow demolition of an existing 17,992 square foot single-family home with an attached two-car garage and detached 3,797 square foot gymnasium; and allow construction of a 7,767 square foot single-family home with an attached two-car garage, 882 square foot basement, 712 square foot pool house, and associated site improvements, including a 1,433 square foot pool and spa. The project is within environmentally sensitive habitat (Monterey cypress forest and coastal bluff scrub), within 50 feet of a coastal bluff, and within 750 feet of known archaeological resources.


