**Project Description**

The California Department of Transportation (Caltrans) proposes emergency erosion repairs on State Route (SR) 26, at post mile 33.9, in Calaveras County. Floodwater from a previous storm eroded approximately 200 feet of the roadside ditch, shoulder, and pavement. The scope of work includes removing a portion of the failing structural section, placing Class 2 Aggregate Base, placing Type-A Hot Mix Asphalt, re-striping, re-grading the roadside ditch, and installing erosion control measures. All work will occur within Caltrans Right of Way. The purpose of this project is to immediately repair the failing roadway, shoulder, and ditch. This project is needed to prevent complete roadway loss and to ensure the safety of the traveling public on SR-26.

If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.
