The project would involve installation of a 24-inch trunk sewer main, approximately 1,400 feet in length, from the intersection of Washington Street and Merritt Street/State Route 183 to the corner of Washington Street and Tembladera Street in the unincorporated community of Castroville, then across undeveloped areas and underneath SR 1 to the M1W pump station located at the south end of Watsonville Road. The proposed 24-inch the existing 18-inch sewer line within Watsonville Road to 18-inch sewer upstream of the existing Monterey One Water pump station. The purpose of the project is to provide additional conveyance capacity from the District wastewater collection system to the M1W pump station, and to improve the accessibility of the sewer line in this location. Pipeline construction would consist of conventional open-cut trench methods and a trenchless crossing to install a segment beneath State Route 1. Project construction would occur over approximately seven months from May 2024 to November 2024.


