

NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION

Notice is hereby given that the County of Fresno has prepared Initial Study (IS) No. 7847 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY NO. 7847 and TENTATIVE TRACT MAP APPLICATION NO. 6323 filed by STRAHM FAMILY, LIMITED PARTNERSHIP, proposing to allow the creation of a five-lot subdivision consisting of four, 2.0-acre parcels and one 3.79-acre parcel from a 12.20-acre parcel, within the R-R (Rural Residential, two-acre minimum parcel size) Zone District. The subject property is located on N. Adair Avenue adjacent to its intersection with E. Ashlan Avenue; and approximately 3.6 miles east of the nearest city limits of the City of Clovis (308-390-75) (13532 Ashlan Ave) (SUP. DIST. 5).

The County intends to adopt the Negative Declaration prepared for Initial Study No. 7847, and take action on Tentative Tract Map Application No. 6323 with Findings and Conditions. (hereafter, the "Proposed Project")


The County of Fresno has determined that it is appropriate to adopt a Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 7847 and the draft Negative Declaration, and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.

## **Public Comment Period**

The County of Fresno will receive written comments on the Proposed Project and Negative Declaration from November 30, 2022, through December 29, 2022.
