TITLE: TENTATIVE TRACT MAP (TTM) NO. 83554

This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 83554). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The proposed project consists of the subdivision of approximately five acres into 18 single-family residential lots in the R-7,000 (single-family residential, minimum lot size 7,000 square feet) zone (TTM No. 83554). The lots range in size from 7,374 square feet to 10,775 square feet. Access into the subdivision would be provided from 59th Street West and Elena Street.

Location: The project site is located on the east side of 60th Street West and south of Avenue K-8 (Assessor's Parcel Numbers: 3204-006-055 and 3204-006-105)

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, and noise.
