The proposed project would rehabilitate six of Turlock Lake's 18 embankment dams for seismic stability and seepage remediation. Dams C, H, J, L, Q and S would be retrofitted for seepage and seismic stability improvements via the placement of buttress fills on the downstream slopes, including chimney drains and a filter-compatible sand and gravel toe drain to safely collect and control seepage. Clearing of trees and woody vegetation would occur at Dams C, D, E, H, J, and L for dam safety purposes.


