Caltrans proposes pavement preservation along Interstate (I) 8 in San Diego County. Work includes Bonded Wearing Course- Rubberized Hot Mix Asphalt (BWC-RHMA) overlay, fog sealing, re-striping, rumble strip installations, and shoulder backing. Except for shoulder backing rehabilitation, all work would be performed on the existing pavement. Shoulder backings would be placed on both sides of the travelled way, up to three feet from the edge of the pavement. See the attached Environmental Commitments Record for commitments.
