The Sutter Butte Flood Control Agency (SBFCA) proposes the Tudor Flood Risk Reduction Project to construct levee remediation measures, including a cutoff wall, a berm tie-in to the SR 99 embankment, pipe penetration improvements, and surficial geometry corrections along the Feather River West Levee (FRWL) from the FRWL confluence with the Sutter Bypass East Levee to just east of SR 99. Improvement measures were developed based on the 100-year design water surface elevation (DWSE).
