Project Title: Bud and Bloom (Project)

Project Location: The Project is located at 1327 ST. GERTRUDE PL, SANTA ANA, CA 92705, in Orange County.

County: Orange County

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 12/08/2017, by Bud and Bloom. The Bud and Bloom applied for a cannabis retail dispensary.

Project Activities:

The proposed project will operate a cannabis retail dispensary out of an existing facility located at 1327 ST. GERTRUDE PL, SANTA ANA, CA 92705 (APN 014-331-15).

The applicant has proposed to use a 5,227 sq.ft. existing building on a 13,188 sq.ft. lot to operate a cannabis retail dispensary.

The project is an existing facility consisting of a single building which was previously used for manufacturing. Tenant improvements were made to the interior to add partition walls and ceilings to create offices, a break room, lobby, reception, and two accessible restrooms. The building was also re-roofed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 3 Categorical Exemption project. Class 3 Categorical Exemptions consist of construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
