The Rose Bowl Operating Company proposes to reorient and expand the existing driving range and construct a new miniature golf facility (Project) within the existing driving range area at the Brookside Golf Course (or golf course). Project improvements would occur on approximately 16 acres within the exiting driving range, Hole 10 of the C.W. Koerner Course, and Holes 6 and 7 of the E.O. Nay Course (Project Site). The Project consists of two main components within the 16-acre Project Site: (1) reorient and expand the existing driving range toward the north; and (2) develop a new miniature golf course adjacent to the west of the proposed driving range.
