The Project proposes to develop two industrial buildings of about the same size, totaling approximately 251,133 square feet (SF). Building A would be 125,568 SF and Building B would be 125,565 SF. Each building would include 12,496 SF of manufacturing use and 10,000 SF of office use. The Project includes the construction of associated parking, landscaping, and utility improvements to serve the site.
