The procedures for recycling, notifying the public of Caltrans intention to consider rescinding a freeway route adoption, and disposing of acquired right-of-way were established by Caltrans and the California Transportation Commission in Resolution No. G-15, adopted on November 17, 1978, and amended on February 29, 1980. Caltrans seeks public comments on rescinding a portion of the freeway adoption for US Highway Route 101 in the counties of Monterey from Post Mile (PM) R91.9 to 101.3 and San Benito from PM 0.0 to 2.9.
