In accordance with the California Environmental Quality Act (CEQA) and the State CEQA Guidelines, the City of San Jacinto (City) (as lead agency) has prepared a Draft Mitigated Negative Declaration (Draft MND) to evaluate the environmental effects associated with the proposed TS Farms Outdoor Cannabis Cultivation and associated development proposal located north of Cottonwood Avenue and west of North Sanderson Avenue, in the City of San Jacinto. The applicant is seeking approval of an outdoor cannabis cultivation site that involves the construction hoop houses. The Project proposes to cultivate approximately 103,000 cannabis plants planted in ground utilizing drip irrigation within approximately 800 set of hoop house structures. In accordance with Section 15072 of the CEQA Guidelines, the City has prepared this Notice of Intent to provide responsible and interested parties with information about the Project details regarding the public comment period and document availability. **Project Title: TS Farms San Jacinto Outdoor Cultivation**  
**Project Applicant: TS Farms (Dawn Williams)**

**Project Description:**

The Project involves the construction and operation of an outdoor cannabis cultivation facility with hoop house structures. The Project would cultivate approximately 103,000 cannabis plants that would be planted in ground utilizing drip irrigation within approximately 800 sets of hoop house structures. The hoop house structures contain metal framing that are approximately 10 feet high, 20 feet wide, and 123 feet long. Plastic sheeting would be placed over the tops of the structures. One harvest per year would occur.

**Project Location:**

The Project site is comprised of 60.53-acres and located north of Cottonwood Avenue and west of North Sanderson Avenue in the City of San Jacinto. The Project site has a City of San Jacinto General Plan Land Use designation of High Density Residential (HDR) and Mixed Use (MU) and a zoning designation of Residential, High Density (RH) and Mixed Use (MU). The Project site is located in Section 29 NW of Township 4 South, Range 1 West and Section 29 SW of Township 4 South, Range 1 West, Lakeview United State Geological Survey (USGS) 7.5-Minute Quadrangle and is comprised of Tax Assessor Parcel Numbers (APNs) 432-130-008, 432-130-009, and 432-130-001.



In accordance with the disclosure requirements of CEQA Guidelines Section 15072, the Project site:

1. **IS NOT** listed as a hazardous property as designated under Section 65962.5 of the Government Code;
2. **IS NOT** a Project of statewide, regional or areawide significance as designated in CEQA Guidelines Section 15206;
3. **WILL NOT** affect highways or other facilities under the jurisdiction of the State Department of Transportation; and

4. A scoping meeting **WILL NOT** be held by the City of San Jacinto. A public hearing will be held and noticed at a later date.

**Public Comment Period:**

The 30-day public comment period for the Mitigated Negative Declaration begins on January 31, 2023 and closes on Wednesday March 1, 2023.
