In accordance with the California Environmental Quality Act (CEQA) and the State CEQA Guidelines, the City of San Jacinto (City) (as lead agency) has prepared a Draft Negative Declaration (Draft ND) to evaluate the environmental effects associated with the proposed Innovative Cultivation and associated development proposal located north of Cottonwood Avenue and west of North Sanderson Avenue, in the City of San Jacinto. The applicant is seeking approval of an outdoor cannabis cultivation site that involves the construction hoop houses. The Project site is comprised of five separate lease areas, each leased to individual cultivators. In accordance with Section 15072 of the CEQA Guidelines, the City has prepared this Notice of Intent to provide responsible and interested parties with information about the Project details regarding the public comment period and document availability. Project Description:

The Project involves the construction and operation of an outdoor cannabis cultivation facility with hoop house structures. The project site is comprised of five separate lease areas, each leased to individual cultivators. Each lease area would contain various support structures and hoop houses for nursery, greenhouse, and drying areas. Canopy area and hoop house sizes will vary per lease area.

Project Location:

The Project site is comprised of 19.28-acres and located north of Cottonwood Avenue and west of North Sanderson Avenue in the City of San Jacinto. The Project site has a City of San Jacinto General Plan Land Use designation of Mixed Use (MU) and a zoning designation of Mixed Use (MU). The Project site is located in Section 29 SW of Township 4 South, Range 1 West, Lakeview United State Geological Survey (USGS) 7.5-Minute Quadrangle and is comprised of Tax Assessor Parcel Number (APN) 432-130-025.



In accordance with the disclosure requirements of CEQA Guidelines Section 15072, the Project site:

1. **IS NOT** listed as a hazardous property as designated under Section 65962.5 of the Government Code;
2. **IS NOT** a Project of statewide, regional or areawide significance as designated in CEQA Guidelines Section 15206;
3. **WILL NOT** affect highways or other facilities under the jurisdiction of the State Department of Transportation; and

4. A scoping meeting **WILL NOT** be held by the City of San Jacinto. A public hearing will be held and noticed at a later date.

Public Comment Period:

The 30-day public comment period for the Negative Declaration begins on January 31, 2023 and closes on Wednesday March 1, 2023.
