Description of Nature, Purpose and Beneficiaries of Project:

Four (4) road segments for a total of 9.4 miles require rehabilitation due to the deterioration of their roadway surface. The road segments will receive a 0.2 ft (2.4 in) single pass overlay. All work will occur within the County's existing right-of-way and will not widen the existing asphalt roadway. Currently the roadway width varies from 20 to 29 feet. Roads are primarily local roads in a residential setting and minor collectors used by local farmers. The following roads are included: Fortna Rd., El Centro Blvd., Seymour Rd., and Garden Hwy.
