This notice is to advise responsible and trustee agencies as well as interested parties and those potentially affected by the project that the City of Lancaster has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the project identified below (TTM No. 82777). The City has determined that the project will not result in significant environmental impacts with the implementation of the identified mitigation measures.

Project Description: The applicant proposes to subdivide approximately 10 acres into 36 single family residential lots in the R-7,000 zone (single family residential, minimum lot size 7,000 square feet.) Lots within the subdivision would range in size from 7,014 square feet to 16,884 square feet. The parcel is currently undeveloped.

Location: The project site is located on approximately 10 acres on the west side of 65th Street West between Avenue J-8 and Avenue J-12 in the City of Lancaster, California. Specifically, the proposed project is located on Assessor Parcel Number (APN) 3203-017-114.

Mitigation Measures: Mitigation measures have been identified for air quality, biological resources, cultural resources, geology and soils, noise, and transportation.


