The project is a request for a tentative parcel map to divide an existing 289-acre agricultural parcel into two parcels of approximately 192 acres (proposed Parcel 1) and 102 acres (proposed Parcel 2) in unincorporated Yolo County within the Clarksburg Agricultural District Overlay. This would allow the winery business to operate independently of the broader family vineyard interests. Parcel 2 would include vineyards, a caretaker's residence, and a historic barn that was permitted by Yolo County in 2018 as a tasting room. Parcel 1 would continue to be used for wine grape production.
