GRANTING OF FUNDING FOR PURCHASE OF A 3,942 ACRE CONSERVATION EASEMENT ON PRIVATE PROPERTY. THE PURPOSE OF THE CONSERVATION EASEMENT IS PERMANENT PROTECTION OF THE PROPERTY TO ENSURE THAT IT REMAIN A WORKING FOREST WITH NO CONVERSION TO NON-FOREST USE AND NO SUBDIVISION OCCUR AT ANY TIME IN THE FUTURE. CONSERVES FOREST, SOIL, AND WATER RESOURCES, WILDLIFE HABITAT, OPEN SPACE, AND SCENIC VIEWSHED QUALITIES OF THE PROPERTY. THE CONSERVATION EASEMENT FOR THE SILVA RANCH CONSERVATION EASEMENT IS BEING PURCHASED BY CALIFORNIA RANGELAND TRUST WITH GRANT FUNDING PROVIDED BY CAL FIRE THROUGH THE CALIFORNIA CLIMATE INVESTMENTS (CCI) FUND TO CONSERVE WORKING FOREST LANDS, SOIL AND WATER RESOURCES, AND WILDLIFE HABITAT IN CALIFORNIA.


Reasons why project is exempt:
