The applicant for the proposed Project is requesting approval from the City of Cerritos to demolish the existing structures on the site and to construct an approximately 159,627 SF industrial warehouse building, including ancillary office uses, parking lot, ornamental landscaping, and associated infrastructure. The proposed building lot coverage will be 50.8%, which is below the allowable maximum of 55% for the Development Area One (ADP-1) zone.
