The proposed project would construct 899 total units which include 5% (45 units) proposed as affordable units (very low). The units will be comprised of 359 one-bedroom, 482 two-bedroom, and 58 three-bedroom. Tentative Tract Map 38373 and Development Plan 2022-2518 proposes the subdivision of 31.39 net acres into two (2) parcels that includes eleven (11) four-story residential buildings and nine (9) two stories carriage style buildings.


