Project Title: WCW Organization Inc (Project)

Project Location: The Project is located at 1628 S GRAND AVE, SANTA ANA, CA 92705(-4807), in Orange County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 02/28/2019, by WCW Organization Inc. The WCW Organization Inc applied for a cannabis dispensary.

Project Activities:

The proposed project will operate a cannabis dispensary out of an existing facility located at 1628 S GRAND AVE, SANTA ANA, CA 92705(-4807) (APN 403-111-08).

The applicant has proposed to use a 2500 sq. ft. existing building on a 35, 121 sq. ft. lot.

There is a gated area to park delivery vehicles. WCW has one company delivery vehicle and with the balance of deliveries handled by vehicles owned by delivery personal.

WCW averages in the area of 500 cannabis transactions per day. Under 5% are medical. Approximately 50 are delivery with 450 retail transactions on a typical day (Project Description).

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
