Project Location: The Project is located at 1631 POMONA RD, SUITE 103 & 104, CORONA, CA 92878, in Riverside County.

County: Riverside

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Non-storefront Retail and Distribution License submitted on 1/6/2022, by Jarod Duggins. Root 91 LLC applied for a non-storefront retail and distribution license out of an existing facility located at 1631 POMONA RD, SUITE 103 & 104, CORONA, CA 92878 (APN 118-040-042). The applicant will store cannabis products for delivery and distribution in 10,116 square foot facility. The non-storefront retail will occupy 658 square feet and the distribution will occupy the remaining 9,458 square feet.

Project Activities:

The Project will consist of 10,116 square feet of distribution and delivery activities. The project will not expand the existing facility and there will be interior tenant improvements.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing building which was formerly used as a storage facility with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
