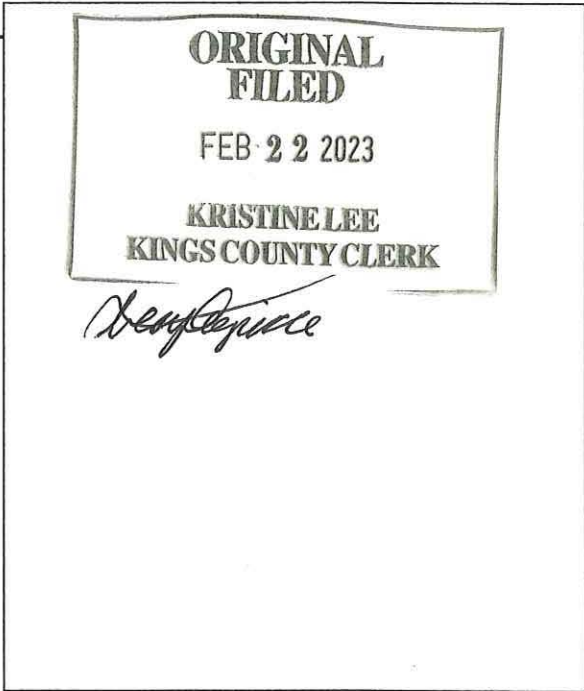

The applicant is proposing to construct a grain silo, an elevated catwalk with connecting towers, conveyors, and an underground tunnel at an existing grain storage and feed mill operation located at 10188 Kansas Ave., Hanford, Assessor's Parcel Numbers 028-220-084 & -083. The proposed grain silo will be 105' in diameter and have a volume of 840,000 cubic feet. The existing truck route will be extended around the proposed grain silo.
