Allow for the maintenance and storage of trucks and trailers when such vehicles are devoted exclusively to the transportation of agricultural products on an existing 2.82-acre parcel within the AE-20 (Exclusive Agricultural, 20-acre minimum) Zone District.

# 9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The majority of the subject parcel is utilized for agricultural purposes. There is a storage shed located on the subject parcel but is located near the southern side while the project will be located on the easter property line. Parcels to the north, east, and south are utilized for singe-family residences.

Per Assembly Bill 52, participating California Native American Tribes were notified of the project proposal and given the opportunity to enter into consultation with the County on the project. No concerns were expressed by the Tribes. A Mitigation Measure has been implemented to address cultural resources should they be unearthed during ground-disturbing activities.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code section 21082.3(c) contains provisions specific to confidentiality.
