Project Description: Allow for the maintenance and storage of trucks and trailers when such vehicles are devoted exclusively to the transportation of agricultural products on an existing 2.05-acre parcel within the AE-20 (Exclusive Agricultural, 20-acre minimum) Zone District. The subject parcel is located on the east side of Shaft Ave, 835-feet north from the intersection of E Dinuba Ave., westerly adjacent to the City of Selma. (APN: 358-240-20) (9798 E. Shaft Ave.) (Sup. Dist. 4).			
Justification for Negative Declaration: Based upon the Initial Study prepared for Director Review and Approval No. 4698, staff has concluded that the project will not have a significant effect on the environment. It has been determined that there would be no impacts to Energy, Land Use Planning, Population and Housing, Public Services, Recreation, Utilities and Service Systems, and Wildfire. Potential impacts related to Agricultural and Forestry Resources, Air Quality, Biological Resources, Geology and Soils, Greenhouse Gas Emissions, Hazards and Hazardous Materials, Hydrology and Water Quality, Noise, and Transportation have been determined to be less than significant. Potential impacts relating to Aesthetics, Cultural Resources, and Tribal Cultural Resources have determined to be less than significant with compliance with implementation of listed Mitigation Measures. A Mitigated Negative Declaration is recommended and is subject to approval by the decision-making body. The Initial Study is available for review at 2220 Tulare Street, Suite A, street level, located on the southwest corner of Tulare and "M" Street, Fresno, California.
