Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Microbusiness License submitted on 2/9/2022, by Elain Lu. ASHE POMONA LLC applied for microbusiness license out of a newly constructed facility located at 2547 POMONA BLVD, POMONA, CA 91768 (APN 8707-015-014). The applicant will store cannabis products for retail, distribution, and cultivation in 10,000 square foot facility.

Project Activities:

The Project will consist of a newly constructed 10,000 square foot facility for cannabis retail, distribution, and cultivation activities. The site will be served by City of Pomona for water and wastewater. Energy will be provided by Southern California Edison.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 Categorical Exemptions consist of being consistent with the City's General Plan and Zoning Code, located within the city limits, project is no more than five acres, substantially surrounded by urban uses, no value as habitat for endangered, rare, or threatened species, no result in any significant effects relating to traffic, noise, air quality, or water quality, and is adequately served by all public utilities. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
