Project Location: The Project is located at 2200 4TH ST, EUREKA, CA 95501, in Humboldt County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Microbusiness License submitted on 8/23/2022, by Jason Miller. KISKANU MFG LLC applied for a microbusiness license out of an existing facility located at 2200 4TH ST, EUREKA, CA 95501 (APN 002-133-003). The applicant will store cannabis products for cultivation, manufacturing, distribution, and cultivation in 1,345 square foot facility.

Project Activities:

The Project will consist of 1,345 square feet of cannabis cultivation, retail, manufacturing, and distribution activities. The project will not expand the existing facility and interior repairs are proposed. The project will add an 8-foot by 20-foot shipping container to the southwest corner of the premises for additional cannabis storage.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.

The Department of Cannabis Control has determined that the project is a Class 11 Categorical Exemption Project. Class 11 Categorical Exemptions consist of construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities.
