The applicant is proposing to install and operate a new Femco Model 26010 20Ton/Hr. Fire Roaster process heater to roast tomatoes seasonally, incidental to the existing Del Monte Foods processing facility. The roaster is equipped with 8 burners rated at 1.25MMBtu for a total of 10MMBtu. The roaster is 25'9" long and 7'11" wide, weighing approximately 18,000lbs. 
