Project Location/Address/City/County: The project is located at 5399 CA-32 Chico, CA 95973 on the left (east) bank of the Sacramento River and within the designated floodway, approximately 1.4 miles east of Hamilton City, Butte County.

Description of Nature, Purpose, and Beneficiaries of Project: To authorize an existing 2805 square-foot dwelling constructed in 1957 and the proposed improvements which consist of; a 20-foot-wide by 40-foot-long swimming pool/spa 3 to 8 foot in depth 620 square feet of 4-inch thick concrete decking, pool equipment and equipment pad.

Reasons Why Project is Exempt:

The Board has determined the project is exempt from CEQA under the Class 1, Existing Facilities; Class 3, New Construction or Conversion of Small Structures; and Class 4, Minor Alterations to Land categorical exemptions (CEQA Guidelines §§ 15301, 15303, and 15304) because the proposed activity consists of the authorization of an existing dwelling and involves no expansion of an existing or former use. In addition, the project activity consists of construction of limited numbers of new, small facilities or structures and the minor private alterations of land and/or vegetation that does not involve removal of healthy, mature, scenic trees. Further, none of the exceptions to the exemption in CEQA Guidelines § 15300.2 apply.
