Project Title: Pacific Coast Bicycle Connectivity North Project (Lake or Streambed Alteration Agreement No. (EPIMS-SMO-42993-R3))

Project Location (San Mateo): The Project is located along the east side of California State Route 1 (Highway 1), Post Mile (PM) 30.99, at Roosevelt Creek, a tributary to the Pacific Ocean, in the County of San Mateo, State of California; Latitude 37.49190, Longitude -122.45190.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-SMO-42993-R3), pursuant to Fish and Game Code section 1602, the project Applicant, City of Half Moon Bay, as represented by Douglas Garrison.


The Project is limited to the construction of a 44-foot-long prefabricated bridge over Roosevelt Creek and associated raised boardwalks. Bridge abutments will be located above top-of-bank, Construction staging will be within the Caltrans right-of-way and in a nearby existing roadway pullout area.
